6. Presentation on and discussion of and action on an Agreement between Bird's Eye View and the EDC on the production of an aerial Helotes map to support tourism. (Staff)

Sarah Echert-Maurer presented an overview of the Bird's Eye View Map and how they are used by local businesses and the tourism industry. She requested the EDC consider two funding options of either \$6,000.00 or \$10,000.00. In exchange for funding, Sarah would allow the EDC to include all business names that would fit legibly, with priority given to retail businesses.
